

## Free Negro and Slave Records, Alexandria County Circuit Court\*

*The sheriff was not only charged with collecting the taxes listed by the county tax commissioners but was responsible for turning the total monies listed into the proper county or state coffers. In order not to be held personally responsible for uncollected taxes he turned in a list of delinquent (i.e., uncollectable taxes). Typical reasons for not collecting taxes include people who had left the area (removed), those unidentifiable (no such person), individuals listed more than once through error (twice charged), and those who were deceased. Often the appearance on a delinquent list as deceased for pre-1853 years (and sometimes even later) is the only record of the death of an individual.* bvl

According to the provisions of this law and one of 1853, this tax was to have been used for colonizing free Negroes in Libera.”<sup>1</sup> The law was rescinded in 1861.<sup>2</sup>* bvl
